Thus the board grades **Luxtriplex**, **Exprint**, **Normprint** and **Normprint Liner** according to the sample material submitted may be used safely for food packaging. They may stand in direct contact with foodstuffs which are peeled, shelled or washed before consumption. The employment as secondary packaging, as well as the packaging of dry, non-fatty foodstuffs can be achieved by using an appropriate intermediate packaging.

This certificate of compliance has a validity of 2 years and consists of 4 pages.
